RULES & INFORMATION

1. The 6th Annual USBC Senior Championships will be held in Time & place to be announced. Winner in each class, if they choose to compete, will be given a paid entry into the National Seniors Tournament. If the winner does not compete, the 2nd, 3rd, or 4th place bowler in each division shall have choice of using the entry and representing Alaska in their respective age divisions.
2. Competition will consist of a classified, handicap singles event with separate divisions for each of the six age classifications as follows:

"Super Seniors" 75 and over "A" 70 - 74 "B" 65 - 69 "C" 60 - 64 "D" 55 - 59 "E" 50-54
"E" Division bowlers do not receive an entry into the USBC Senior Nationals. They will receive prize money for their division and an opportunity to participate in the USBC Senior Masters.
3. Classification at the USBC Senior Championships will be determined on the basis of the age of the bowler at the time of participation in the state competition.
4. Alaska is permitted to send a maximum of five bowlers to the USBC Senior Championships, the first place handicap all events winner in each of the five age divisions. If a tie exists for the championship of a division, co-champions shall be declared - for purposes of determining who shall be eligible for the USBC Senior Championship, this shall be determined by the player with the highest scratch game moving forward. If a tie still exists the second highest game will be used.
5. If the State Champion in any division is unable or declines to attend the national event, the second, third and fourth place finisher will have to option to attend. Alternate selections will be made in the order of finish and only those bowlers in the top four places will be eligible.
6. All senior members of any USBC bowling association in the State of Alaska are eligible to enter. Seniors living within the State of Alaska who are not members may enter by paying an unattached membership fee of \$20.00
7. Entry Fee is \$30.00 per person. Entry fee must accompany the entry form. This tournament will consist of bowling six (6) games, three (3) on each of 2 different pairs of lanes. Bowling fees \$18.00, prize fees \$10.00, expense Fee \$2.00. Prize fee will be returned 100%. Each division is paid 1 - 6 in their respective divisions based on entries in each division.
8. No Refunds of entry fees after the first frame has been bowled.
9. Averages:
 - A. Highest ABC 2009 - 2010 Book Average will be used, based on a minimum of 21 games.
 - B. If no 2009 - 2010 Book Average, the highest current average with a minimum of 21 games. Verification must be provided at the time of bowling.
 - C. If no average under Rules (1) & (2) entering average will be 210Multiple entries are allowed with a possible maximum of 5, but the bowler may only place once in the prize list.
10. Handicap: Handicap will be 90% of the difference between the bowlers average and 210.
11. USBC Rules 319d, 319e and 319a-3 regarding reporting prior prize winnings, average adjustments and bowlers responsible for verifying their own averages will be enforced..
12. All winners must provide verification of their age.
13. Entries close 3:00 PM November 1st 2010
14. All bowling will be held at Eagle River Bowl Eagle River Alaska
15. All sanctioned Males who sanctioned in Alaska are automatically members of the ASUSBC.

USBC Senior Masters

Alaska Bowling Proprietors Association will pay the entry fee and provide \$500 expense money for the winner.

1. High scratch 6 game total rolled by a senior will be named the USBC Senior Masters winner.
2. USBC requires a minimum league average of 190 for all Senior Masters entrants.
3. Current card carrying PBA Members are not eligible
